We invite you to celebrate this milestone event with us as an emerging artist, continuing the annual tradition of connecting artists with our central Indiana community. The mission of the Indianapolis Art Center is inspire creative expression in all people by providing interactive art education, outreach to underserved audiences, support to artists, and exposure to the visual arts.

EMERGING ARTIST AREA IS BACK!

The Indianapolis Art Center is very excited about bringing back the Emerging Artist Student Sale to the OneAmerica Broad Ripple Art Fair. This year, students will again be able to participate in the sale of their own artwork while interspersed amongst other participating professional artists. This is a great opportunity for students to build comradery among other students and artists, to sell their work, gain experience working with patrons, and explore making the leap into professional art making.

ARTIST BOOTH FEES FOR THE WEEKEND: \$100 FOR 1 TABLE / \$200 FOR 2 TABLES

This year we are giving the emerging artists the choice of how much space they will need. Booth fee is \$100 for one 6 foot table (or equivalent in ground space with no table) for the weekend. You can purchase up to one additional table (or ground space equivalent) for your work. Please note that if you purchase 2 tables, they will most likely be arranged in an “L” configuration to allow for more artists in the tent space. Tables will not be end to end.

STUDENT ELIGIBILITY:

- Indianapolis Art Center students who have taken at least one class or workshop since January 2019, any local college students who are currently enrolled and in their sophomore, junior, or senior year, or are a graduate student, are invited to participate in the Emerging Artist area of the OneAmerica Broad Ripple Art Fair.
- Students may not sell any work outlined as ineligible in the prospectus (available at www.zapplication.org or via email by request), and they may not sell work that is packaged, licensed, or distributed for mass sale (“buy-and-sell” items).
- The Emerging Artist area will be located in the Lower Terrace area. There will be a series of professional grade tents 10’ deep x 20’ wide (provided by the Art Center). Each tent will be shared by up to four students.
- There are limited spaces available for students this year. Students will be selected by jury process. Students will be notified on Wednesday, April 13th, regarding acceptance.
- Students will be responsible for handling their own sales and sales tax. There is **NO COMMISSION TAKEN** by the Art Center on your artwork sales.
- Students are responsible for all of their own packaging, wrapping, receipts, and other materials the student deems necessary for their sales.
- Indianapolis Art Center faculty members are not eligible for participation.
- Students must be 18 or older to participate, must sign the Risk and Liability Statement (see last page), and are responsible for their own insurance.
- The fee to participate, due by April 22, is \$100 for 1 table and \$200 for 2 tables, for the weekend. Keep in mind there is **NO COMMISSION TAKEN**, so this is the only fee.
